# PROJECT TO IMPROVE ACCESS TO GEORGETOWN FROM THE REGIONAL METRORAIL SYSTEM KICKS OFF

**Washington, DC (June 2, 2021)** – The Georgetown BID, Federal City Council, and District Department of Transportation have formed a partnership to advance planning for improved transit between Georgetown and Metrorail. This \$250,000 initial environmental planning effort is funded by the District of Columbia. The work is being managed by the Federal City Council.

Georgetown is a major jobs and activity center that does not have a Metrorail station. Transit to and through the neighborhood is slow and unpredictable because of neighborhood and citywide vehicle congestion. This limits access to Georgetown for employment, recreation, education, and commercial activities. Reliance on single occupancy vehicles for access contributes to traffic congestion and exacerbates the problem of limited access for drivers and non-drivers alike.

The purpose of this one-year project is to identify a preliminary range of alternatives to provide direct, frequent, rapid transit between the Metrorail System and Georgetown prior to the publication of a Notice of Intent to Prepare an Environmental Impact Statement (NOI) to formally begin the National Environmental Policy Act (NEPA) process, which will include significant opportunities for public involvement and feedback. The focus of this phase will be on refining the project's Purpose and Need, developing draft alternatives for later public review, and identifying resource impact areas.

The preliminary range of alternatives will be developed and screened to address the Purpose and Need, and may include transit solutions like Bus Rapid Transit, a gondola system, and multimodal connections. Alternatives will leverage robust stakeholder input and relevant studies and analyses that have been done since the completion of the 2016 Georgetown-Rosslyn Gondola Feasibility Study, including the WMATA Blue, Orange, Silver Line Study; the 2019 Core of Rosslyn Transportation Study; Environmental Assessments for the Georgetown Non-motorized Boathouse Zone and the Arlington County and Vicinity Non-motorized Boathouse Facility; the Georgetown University Campus Plan; and others.

Work is anticipated to begin in May 2021 and last for one year. The Federal City Council has engaged VHB Metro DC, LLC with its partner SCJ Alliance, to complete this phase of work. The National Capital Planning Commission (NCPC) will be serving as the lead federal agency for the

purposes of NEPA. At the end of the phase, the partners with NCPC will decide which, if any, of the alternatives to move forward for further development. QUOTES
